RE-ENGAGEMENT AFTER EXPIRY/TERMINATION OF HIS/HER CURRENT CONTRACT. THE RAILWAY ADMINISTRATION HAS FULL RIGHT TO RESERVE TO DISCONTINUE CONTRACT RE-ENGAGEMENT AT ANY STAGE. ALL OTHER TERMS AND CONDITIONS AS LAID IN RAILWAY BOARD'S LETTER NO-EN011205/RC-45C2 DATED 31.03.2020 AND OTHER AS CIRCULATED FROM TIME TO TIME SHALL BE BINDING UPON THE PARA-MEDICAL STAFF.

1. Since the posts are over and above the sanctioned posts due to the engagement on contract basis as prescribed conditions, distribution of 50% EOP will be applicable. However age relaxation will be given to candidates belonging to SC, ST, OBC, Pw-BE (category) as per extant rules. Age will be reckoned as on the date of notification.

2. Period of Contract: The engagement is purely on contractual basis for three months only. The service rendered in re-engagement of Para-medical staff is an arrangement for meeting of the requirement of the pandemic situation of COVID-19 and it will not confer any right for automatic regularization/absorption in any circumstances. The full time medical staff who enters into contractual engagement with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term contract. Re-engagement after expiry/termination of his/her current contract. The Railway Administration has full right to reserve to discontinue contract re-engagement at any stage. All other terms and conditions as laid in Railway Board's letter No. EN-011205/RC-45C2 dated 31.03.2020 and other as mentioned from time to time shall be binding upon the Para-medical staff.

3. Remuneration: (i) The following will be monthly consolidated remuneration for full-time contractual para-medical staff.

4. Daily rate of deduction per day from the pay for absence may be pro-rata basis.

5. Mode of selection will be walk-in-interviews however in prevailing conditions of lockdowns walk-in for interview will be conducted either in person or through online platforms like WhatsApp etc. For in-interview walk-in date and time, candidates will be informed by e-mail/phone. However if Para-medical leave without notice or before completion of 15 days notice, he/she shall be liable to pay the amount for the period as per prevailing rates.
